RESOLUTION No. 14

"A RESOLUTION MANIFESTING CO-OWNERSHIP OF THE MAPPING RESEARCH PROJECT-BASED AT SOAS, UNIVERSITY OF LONDON AND TO ALLOW BAI MARIBETH B. FARNAZO, RESEARCH FELLOW TO CONTACT INTERESTED PARTICIPANTS IN THE INDIGENOUS CULTURAL COMMUNITIES TO ATTEND AND CONTRIBUTE TO THE DISCUSSION WORKSHOP."

WHEREAS, pursuant to Article 14, Section 15 of the Philippine Constitution Provides, All the country's artistic and historic wealth constitutes the cultural treasure of the nation and shall be under the protection of the State which may regulate its disposition;

WHEREAS, section 17 of the 1987 Philippine Constitution also provides, The State shall recognize, respect, and protect the rights of indigenous cultural communities to preserve and develop their cultures, traditions, and institutions. It shall consider these rights in the formulation of national plans and policies;

WHEREAS, on June 24, 2022, Bai Maribeth B. Farnazo, one of the research fellows of the project appeared to the Provincial Tribal Council (PTC) for co-ownership of the mapping research project;

WHEREAS, after Bai Farnazo's appearance and presentation of the project, the PTC clearly appreciated the noble intention of the research team members working on digital humanity that seeks to create a visual inventory of Philippine Material Culture that is stored in collections outside the Philippines. Moreover, the PTC assessed the purpose of the research of connecting those outputs with their cultural bearers whether or not they can still recognize those artifacts to the present. As such, it is deemed concluded a strong response to intensifying cultural promotion, preservation, and protections enshrined in the IPRA law of 1997 and therefore worthy to emulate;

WHEREFORE, the PTC further manifests its support to the mapping research project provided, however, it upholds the SOAS declaration of assurance of the confidentiality of information, IPS co-ownership of the project, and a guarantee to give back the output and full authority to the PTC in using it as a reference;

NOW, THEREFORE, be it resolved, as it is hereby resolved, on unanimous accord by the officers of the PTC as the highest Indigenous Political Structure of the Province to allow BAI MARIBETH B. FARNAZO, to assist in the conduct of workshops and to contact the interested participants for the workshop on motion of Fulung Fredo P. Basino, PTC-Adviser/Consultant (Bong Fulung Mngawe Banwe) duly seconded by Fulung Romeo L. Martin, SIPPA-President and Datu Kubli Kusin, Vice-SPTC.

RESOLVED FINALLY, to furnish a copy of this resolution to *Bai Farnazo* and her SOAS team for information and guidance.
